If you would like to have a gate code assigned to your personal vendors, please fill out the form entitled **Estates Gate Access Information for Personal Vendors**.

- **Resident Entry Code:** Your 4 digit entry code is specific to your personal profile. When this code is entered into the keypad the gates will open. Be sure to press the enter button after you enter the code. **This code is CONFIDENTIAL. PLEASE DO NOT GIVE THIS NUMBER TO ANYONE NOT LIVING IN YOUR HOME.**
- **Guests/Deliveries:** When a visitor or delivery driver would like to gain access into the community they can select your name from the directory. The keypad will call the main phone number you have listed on this form. If no one answers, the call will forward to the alternate number. When you answer the phone simply press the number 9 and the gates will open.
- **Resident Directory Code:** (This code will not be changing.) Your directory code is specific to your name listed in the directory. You may give this code to your guests/delivery personnel. When this code is entered into the directory it will display your name on the screen. Your guest/delivery personnel can then call you from the keypad and request access into the community. When you answer the phone call simply press the number 9 and the gates will open.
- **Gate Remotes and Fobs:** These will not be changing, but the replacement costs are as follows: Gate remote cost is \$45. Pedestrian gate fobs are \$10.
